THIS FRIENDSHIP CENTERS PROGRAM TAKES A HOLISITIC APPROACH THROUGH CONGREGATE DINING FOR ADULTS AGED 60+ IN A PLEASANT SOCIAL SETTING. MEALS ARE SERVED IN HUB SENIOR CENTERS AS WELL AS IN MULTIPLE NEIGHBORHOOD LOCATIONS. THESE SITES PROVIDE SOCIALIZATION, ENTERTAINMENT AND CAMARADERIE FOR SENIORS WHO MIGHT OTHERWISE EAT ALONE OR NOT AT ALL. THIS IS ESPECIALLY IMPORTANT FOR THOSE WHO HAVE LOST A SPOUSE AND NEVER LEARNED TO COOK, FOR ELDERS WHO ARE DEPRESSED AND SKIP MEALS BECAUSE THE THOUGHT OF DINING ALONE IS DIFFICULT, OR DON'T DRIVE ANY LONGER THEREFORE MAKING SHOPPING A CHALLENGE.

ADDITIONALLY, THIS ELDERCARE NUTRITION PROGRAM ALSO PROVIDES

SUPPORTIVE AGING - REMAINING INDEPENDENT IN THEIR OWN HOMES IS PARAMOUNT TO SENIORS AND THE FRIENDSHIP CENTERS CASE MANAGERS HELP TO MAKE THIS A POSSIBILITY. CASE MANAGERS CONDUCT IN-HOME ASSESSMENTS FOR FINANCIALLY QUALIFIED INDIVIDUALS TO DETERMINE A CARE PLAN THEN IN-HOME SERVICES ARE COORDINATED BY THE CASE MANAGERS.

FRIENDSHIP AT HOME IS A THREE-PRONGED SERVICE OFFERING VOLUNTEER TELEPHONE REASSURANCE CALLERS, FRIENDLY VISITORS WHERE A VOLUNTEER IS MATCHED WITH A HOMEBOUND ELDER TO PROVIDE CONNECTION AND A CARING RELATIONSHIP, AND FINALLY ECONOMIC STABILITY THROUGH CRISIS INTERVENTION. THIS LAST COMPONENT OF FRIENDSHIP AT HOME HAS A COUNSELOR WORKING WITH INDIVIDUALS DEALING WITH BOTH LIFE AND FINANCIAL HARDSHIP.
